PARTA EXECUTIVE BOARD MEETING MINUTES 10:00 AM Monday, January 31, 2022

DESCRIPTION

President Wheeler addressed the recent lawsuit filed by the Illinois Retired Teachers Association against the State of Illinois. The lawsuit is seeking to correct an unconstitutional move by the State which dramatically reduces contributions made to the Teacher Health Insurance Security Fund. Please go to the IRTA

PARTA officers and committee chairs were encouraged to complete the job description for their respective office and committee. The officers' and chairs' responsibilities will become part of the record and posted on PARTA's website. At the next Board meeting the job descriptions will be submitted and tweaked before placing them on the website. A timeline will be included in the report to reflect the completion

of the activities required of the positions.

Denise Smith is in the process of completing the PARTA directory for this year. She thanked Roger Hampton for his assistance. Pat Hampton will assist in the proofreading as to grammar and mechanics but will not verify the accuracy of the historical information placed in the directory. Dixie will provide updated changes to the by-laws for the directory. Denise Smith went through the sub-sections included in the directory. There was additional discussion regarding the extent of advertisement and ads in the directory. It was decided a conversation with Trent Strong from our investment firm will take place after the February meeting to seek assistance from them in purchasing an ad in the directory. The finance committee members will follow up on talking to Trent Strong



PRITZKER'S FY2023 BUDGET REAFFIRMS A COMMITMENT TO TRS MEMBERS

Governor Pritzker's plan to appropriate more money than the minimum requirement to Illinois' public pensions in fiscal year 2023 was praised by TRS leaders as a commitment to improve the retirement security of the state's teachers.

"Pritzker's proposal to allocate \$10 billion to public pensions in the coming year's state budget reaffirms his strong partnership with generations of Illinois teachers," said TRS Board President Matthew Hunt. "Since taking office, Pritzker has proven to be very supportive of our 432,000 members and their futures." In his FY 2023 state budget proposal, Pritzker said he wants to add \$500 million to the minimum annual contribution required by law to TRS and the other pension systems. In FY 2023, the state's minimum statutory payment is \$9.6 billion, with \$5.9 billion dedicated to TRS. With the additional funds, the

state's total contribution to the pension systems will be \$10.1 billion. It's expected the payment to TRS will total \$6.16 billion.

Governor Pritzker said the added \$500 million will reduce the future long-term liability of the state's pension systems by an estimated \$1.4 billion. The total long-term liability of all of the state's five pension

systems currently stands at \$236.5 billion. The TRS unfunded liability is \$80 billion.

As seasonal discount shopping goes, March isn't the biggest month for bargains. Retailers are more focused on making the transition from winter to spring than they are on hosting huge sales or extending at markdowns.

"There is no major commercial spendingfocused holiday in March, like the winter holidays or Presidents Day, or even back-toschool shopping," said Rebecca Gramuglia, a consumer expert.

The absence of a major shopping holiday, however, doesn't mean no good deals can be had in March. Look for freebies and discounts on pizza and pie on Pi Day as well as some sales on green apparel for St. Patrick's Day. Otherwise, retail experts say the best sales will reflect inventory that retailers want to clean out to make room for new stock.



Growing up, Diondre Ouzts says he was never motivated or inspired by learning. For him, school was always more about sports and socializing than academics. By the time he made it to high school, his athletic talents were his primary reason for attending. Several setbacks and mistakes caused him to become academically ineligible to play high school football.

Feeling defeated and disappointed in his fate, Diondre ultimately decided to drop out of school and never imagined he would obtain his high school diploma.

Inspired by his mother's positive experiences with *The Excel Center*, a charter high school operated by *Goodwill of Greater Washington* (DC), Diondre enrolled to obtain his high school diploma. He says enrolling in the College and Career Readiness program changed his life tremendously. Inspired by one of his instructors, he developed a love for learning, which led to a passion for teaching. That desire carried Diondre through his tenure at The Excel Center, and he made it his mission to graduate. During his time there, he honed his leadership skills and felt led to help other youth like him learn and prepare for life. Diondre graduated and is now working with *The Literacy Lab*, tutoring young minds.

A group of retired Illinois educators is suing the state over what they say is a diminishment of promised benefits. Some see it as another example of the need for constitutional pension reform. The state is reducing by around \$100 million per year what taxpayers pay for retired teachers' health care starting July 1, 2022. The Illinois Retired Teachers Association said it filed a lawsuit against the Teachers Retirement System Board of Trustees, the Pritzker 00 administration, Illinois comptroller, Illinois treasurer, House Speaker, and Senate President in Sangamon County Court. Retired teacher Pat Hampton said the reduced state contribution would mean increased costs for retired teachers like herself. "It would just be financially, physically, mentally, in so many ways devastating to me," Hampton told WMAY Monday. The IRTA is seeking to require the state to pay a "sufficient" amount. "Our actuary has come forth and said anywhere from one to four years the fund could go belly up," IRTA Executive Director Jim Bachman said. Wirepoints President Ted Dabrowski said the unfunded health care liabilities are a real concern for beneficiaries. "The state has grossly underfunded its obligations," Dabrowski told The Center Square. "By the same token, taxpayers should be really scared too because they're going to be on the hook for over \$70 billion in these unfunded retiree health insurance costs that nobody seems to know how to pay for." IRTA officials also said the state's reduction would be a diminishment of promised benefits protected by the Illinois Constitution. Dabrowski said all of Illinois' public sector pension funds are \$140 billion unfunded and this latest lawsuit highlights additional unfunded taxpayer costs for retiree health care. "It's a \$70 billion shortfall," Dabrowski said of the unfunded health care costs for public sector retirees. "So, it's back to the same discussion of we need a constitutional amendment to reform all these debts that we have that the taxpayers are going to be on the hook for eventually." Such proposed

The Excel Center prepared Diondre for his future through a comprehensive curriculum in business administration and communication skills that focuses on developing high-level communication skills and

confidence in each learner's abilities. Diondre is now preparing to start his own nonprofit organization for youth who face disadvantages in their lives.

As a result of the services *The Excel Center* provided, Diondre was able to refocus on his academics and receive the support he needed to reach his goals. Through his nonprofit, Diondre will use sports as a metaphor for education and envisions other more academically focused clubs like chess and robotics.



"Through [The Excel Center], I met so many new people willing to help me work and get my organization off the ground," he says. "I thank the Goodwill community for everything." In addition to his full-time fellowship at The Literacy Lab, Diondre received a full-tuition scholarship to attend Catholic University to pursue early childhood education. He was also recently awarded Goodwill Industries International's Kenneth Shaw Graduate of The Year Award. Diondre is a shining example of what hard work, perseverance and commitment can do to propel someone to the next level.
