#### BOARD OF DIRECTORS' MEETING (VIRTUAL)

The PARTA Board Meeting started at 10:03 AM with President Dixie Wheeler presiding. The members present were: Roger Hampton, Dixie Wheeler, Patti Monks, Jeff Vallosio, Peggy Shane, Dave Barnwell, John Rathbun, Jeannie Blane, Valda Shipp, Sally Weber, Susan Leighty, Abby Humbles, and Deloris Turner.

President Wheeler posed some questions to the Board regarding membership input, with references to what we do as a Unit. John Rathbun felt there has always been some level of input. However, the current meeting setting makes it hard for members to participate actively.

Some suggestions to generate membership input: filling out cards and not requiring the person's identity and placing a suggestion box at the back of the meeting room; pose topics to incite

thinking and discussion among the membership; ask members to recruit other members; use the comment section of the PARTA website; a display with names of the retiree and their district displayed at meetings: members at the meeting could connect with these individuals.

Sally Weber stated that our mission statement focuses on Advocacy, Education, Cooperation, and Socialization. Sally felt we currently hit on all of them. She suggested since membership is our focus this year, it would be prudent to stay with

I need one or two people who would be willing to sit at the back table and check people in each luncheon meeting each month. This is also a very important job and so very necessary to the smooth running of the luncheons.




the June meeting you may leave me a note with your information. THANK YOU, Cora Coleman and Pat Jackson. Cora and Pat have served as callers and have also



#### *Sharpe's Fortress* by Bernard Cornwell

Critically acclaimed, perennial New York Times bestselling author Bernard Cornwell makes real history come alive in his breathtaking historical fiction. In the history of America, only one woman has ever received the Medal of Honor: Dr. Marv Edwards Walker. However, Mary's life was more than just a medal. Not only was Mary a leading suffragist, the first female surgeon to serve in the United States Army, and an advocate of women's dress reform, she was a woman who put the lives of others before hers. She sacrificed her personal happiness, her comforts, and her reputation in order to fight for the ideals she believed in, both during and after her service in the American Civil War. Mary was a nonconformist in every way, refusing to bow down to society's establishments. When society towered above her, demanding her to surrender, Mary planted herself like a tree and stood her ground. Mary's life is a testament to the idea of selflessness. Today, many Americans stand on her shoulders. This book is more than a simple biography of Mary's life. Instead, this book seeks to understand the woman behind the medal. It seeks to discover the core of Mary's being and the inspirations that turned her into who she was.

#### **CRITIQUE OF "WHAT NEWSPAPERS ARE REPORTING"**

(Capitol Fax article printed in the April Soundings) As the State of Illinois considers the ILLINOIS budget, spending, and taxes, it is of importance to teachers, and particularly retired teachers, to pay attention. The State of Illinois continues to underfund our TRS pension

system in order to use the money for current day expenditures thus allowing continued avoidance of



taxing to pay for the levels of spending that are approved. This problem should be clear to anyone who has paid attention to what continues to occur year after year. While state officials may say they are funding the pension levels needed to pay current retirees they have continued to fail to put into the system the money needed to provide for future benefits. The only reason the TRS has



continued to survive is because of an overall good investment result. If the stock market tanks, TRS (and other Illinois retirement system) retirees are in for a scary

and difficult time as the current funding by the state would need to increase and there is not money for that. This is the same problem with Social Security--it is easy for the federal and state governments to spend money rather than "to save it in the bank" for future retirement commitments.

PARTA need to continually remember that while we have a

nice investment portfolio, we need to resist the temptation to see a pot of money that we can spend on various good projects. The money paid for life membership, like the pension systems, should be reserved for the

future needs of those Reserve Funds who have paid into the system and have



every rightful expectation to receive the benefits for which they have paid. While news reports and Governor Pritzker's budget address may say "Illinois state government already spends less money per person than the majority of states in the nation", they left out the important fact that much of Illinois' educational spending comes from the local level and not the state government. That is not so in other states. Thus, while the statement may be true as written, it is not a fair comparative statement concerning total spending. Some "Pinocchios" should be assessed to both the governor for saying that and the media for not pointing out the unfair comparison.

What the article should have said was that both more cuts in spending over the long term and general tax increases also over the long term will be required because of decades of overspending and "borrowing" from the pension funds.

#### WINDFALL ELIMINATION PROVISION (WEP) & GOVERNMENT PENSION OFFSET (GPO)

WEP, enacted in 1983, reduces the Social Security benefits of workers who receive pensions from a federal, state, or local government for employment not covered by Social Security. {affects nearly 2 million retirees)



GPO, enacted in 1977, reduces or eliminates Social Security spousal benefits for spouses, widows, and widowers who receive even partial pensions from a federal, state, or local government. (affects more than 700,000 retirees, 83% women, 71% lose ALL benefits)

WEP and GPO cut the earned benefits of more than two million retirees.

## PUBLIC EMPLOYEES AFFECTED

- TEACHERS IN 15 STATES: AK, CA, CO, CT, GA, IL, KY, LA, MA, ME, MO, NV, OH, RI, TX
- STATE, COUNTY, CITY, AND SPECIAL DISTRICT EMPLOYEES IN 26 STATES
- FEDERAL EMPLOYEES WHO ARE ON THE CSRS RETIREMENT SYSTEM IN EVERY STATE
