
I want to thank everyone for all their support and kind words. Taking over this job was a labor of love. Nancy Wing had this volunteer position down to a

# TRS ANNUAL INCREASE REFLECTED ON FEBRUARY 1<sup>st</sup> CHECK

**Teachers Retirement System (TRS)** pays your monthly benefit in arrears. The check issued January 1, 2020 is your payment for the month of December 2019.

Cost-of-living adjustment (COLA) increases, certain insurance premiums and federal tax withholding changes will be reflected on the check issued February 1, 2020, which is your 3% monthly annuity for January 2020.

The annual 3% COLA will be reflected on your February 1, 2020 check. With some exceptions, recipients of monthly survivor benefits will also see a 3% increase. The COLA increase is first effective on January 1 following either your first retirement anniversary or your 61st birthday, whichever is later. TRS only sends a notification letter before your first COLA occurs. Retirees may log in to the secure Member Account Access area to view their monthly and annual earnings statements.

Chicago is the most corrupt city, and Illinois the second-most corrupt state, in the nation, according to a 2019 report by the University of Illinois at Chicago.

## **CORRUPTION IN ILLINOIS IMPACTS GROWTH RATE ILLINOIS GROWTH SLOWEST OF FIVE LARGEST STATE ECONOMIES**

Corruption in Illinois comes with social and economic costs. Not only does corruption lessen residents' faith in the government. it decreases economic growth and disincentivizes investments in the state.

It is estimated that Illinois' public corruption convictions cost the state economy an estimated \$550 million every year since 2000, totaling more than 10 billion dollars!

Federal corruption convictions per capita were 8% more common in Illinois than in other states during that time period.

Illinois' role in the national economy has declined steadily since the 1960s. An economy that was once the third-largest contributor to the nation's GDP has continued to slip. This shouldn't come as a surprise, because states with higher levels of corruption on average see lower levels of investment and economic growth. Using data from all 50 states, corruption was found to play a significant and causal role in reducing economic growth. Illinois ranks 40th in cumulative economic growth, out of 50 states and Washington, D.C., in gross state product since 1997. With real economic growth of just 1.35% annually on average, Illinois trails the U.S. economy with real economic growth of 2.31%. Source: Bureau of Economic Status - www.illinoispolicy.org/reports/



# NEW YEAR - NEW ILLINOIS LAWS

On January 1, 2020, more than 250 new Illinois laws went into effect, such as:

**HB 3113:** Health insurance policies will soon also have to cover one annual office visit for a whole-body skin examination for lesions suspicious for skin cancer, without charging the patient a deductible, coinsurance or co-payment.

**HB 2146:** Requires UIC School of Public Health and IDPH to convene a working group to come up with policy recommendations relating to the health of Illinois residents. HB 3503: Requires insurers to offer optional coverage for hearing instruments and any related services for all individuals 65 years old and older when so prescribed by a hearing care professional.

**SB 69:** Tightens up statutes to ensure those who commit crimes against elderly and disabled persons are held accountable.

# HB 2700: (AN IRTA INITIATIVE)

Requires Illinois Central Management Services to identify a situation where a Teacher's Retirement System recipient overpaid for health insurance and refund the overpaid amount as soon as practicable.
