Governor Sued By His Wife's Non-Profit

The number of social service groups suing Illinois is growing. Eighteen agencies are joining a lawsuit against the state to get paid – since they haven't received \$130 million due to the budget impasse. One of the latest groups to sue is notable because of who's in charge.

Governor Bruce Rauner is being sued by his wife. Well, her organization anyway. Diana Rauner is the CEO of Ounce of Prevention, a nonprofit that's owed \$6 million dollars from Illinois per a contract. Ounce's Chief Operating Office Sarah Bradley says there's nothing to make of the First Lady's involvement in the lawsuit.

"This was a business decision that we made with the support and leadership of Diana and the support of the board. And this is for us about fairness and our contracting with the state," she said. "We do hope that this lawsuit brings attention to the fact that the social fabric is fraying as a result of this state budget impasse." Bradley says Ounce of Prevention has continued providing support services to teen moms, even though it's been waiting for Illinois to pay since July.

<u>Illinois Legislative News</u>

SB 250 passed in the Senate allowing automatic voter registration in Illinois. It would allow for the automatic registration of eligible Illinois residents to vote when they apply for or renew a driver's license or state ID card unless they opt out. Proponents say the bill also would clean up and update voter files.

SB 2931 passed both the Illinois House and Senate. This would raise the base salary for home care workers from \$13 to \$15 an hour. Roughly 24,000 workers care for disabled residents in their homes.

MAP GRANTS The Illinois General Assembly has passed another bill that would provide money for grants to low-income college students, but it faces a likely veto from Governor



Rauner. The latest proposal is similar to previous bills the governor opposed. It would authorize spending \$227.3 million dollars to fully fund MAP grants for the 2015-16 school year. The earlier bill Rauner signed provided \$167.6 million. The major difference – and the major sticking point for Rauner and his fellow Republicans – is that there is no specified funding attached to the new bill. The GOP argues that the state is already spending more than it will bring in this year.

Rauner Laughs At Cullerton Suggestion That Pensions, AFSCME Contracts Are Tied

It's been a year since the state Supreme Court found Illinois' big pension law unconstitutional, and a Lawmakers' attempt to get a new law passed is stalled. The goal is to reduce the state's expenses for its vastly underfunded pensions. The court says it's illegal to do it by reducing employees' retirement benefits. Senate **President John Cullerton** and Governor Bruce Rauner think they have a way around that.

The idea is to push employees to opt-in to earning a lesser pension benefit; those who don't would have it forced on them in a roundabout way, by not applying future salary hikes toward their pensions (the idea being that raises aren't constitutionally guaranteed). Though it's Cullerton idea, he says there's a reason that the Senate hasn't voted on it. "It's very difficult to pass a pension bill with union opposition, and I can empathize with the folks from AFSCME who don't know what their salary is going to be for the next four years or what their health care package is going to be. So it's kind of difficult to ask them to sacrifice their pensions when we don't even know what their contract is. So if the governor's interested in helping us pass a pension reform he's going to need to deal with the contract with the unions."

Rauner literally laughed aloud at the notion when asked about it at a press conference Monday. "I love John, That comment's kinda goofy," he said. "I mean, here's the issue: he's advocated for pension reform. I'm advocating his plan. That has nothing to do with anv particular round of contract negotiations. They're not related."

Independent Map Amendment Passes Petition Test

A state review of Independent Map

Amendment petitions indicates the submitted petitions likely contain more than the minimum 290,216 valid signatures of registered voters required by law to place the proposed redistricting reform constitutional amendment on the November ballot.

"The citizens of Illinois have signaled very clearly with their signatures that they want legislative redistricting reform on the November ballot," said Dennis FitzSimons, Chair of Independent Maps. "The huge number of petition signatures is yet another sign of the strong statewide support for an independent, transparent, and impartial process for drawing state legislative maps. Now that the petition review process is complete, we can focus on fighting the lawsuit filed by entrenched political interests looking to deny citizens the chance to change the system," FitzSimons said.

Will a State Tax Increase Be Coming Soon?

Talk of a tax hike looms in Springfield as lawmakers face a growing state deficit and a week to go before blowing yet another budget deadline. An income tax increase and an expansion of the sales tax onto more purchases were part of a "framework" that some rank-and-file lawmakers sent to leaders last week. But a look back at the political climate that ushered in Illinois' 2011 income tax hike (and subsequent rollback) shows how difficult it might be for Democrats and Republicans in a divided Springfield to make a decision on taxes this time around.

n January 2011, Democrats barely mustered the minimum number of votes needed to approve an income tax increase from 3% to 5% in the overnight hours before a new class of lawmakers was to be sworn in. It was two months after the election. Voting for a tax increase can be hard even for a lame-duck lawmaker, and some who did, subsequently landed in state jobs.

This year, a tax increase isn't the only thing preventing agreement on a state budget as Republican Governor Bruce Rauner continues to push lawmakers to approve goals he argues will improve Illinois' business climate. Crucially, the November election is ahead of lawmakers, not behind them. It could help define whether Rauner gains allies in Springfield or loses more ground.

n campaigning against former Governor Pat Quinn two years ago, Rauner criticized the Democrat for the income tax hike and released a plan that called for tax rates to go down by the end of his first term. Now, Rauner says he is open to a tax increase if Democrats sign off on some of his policy goals. "If we put in a big tax hike to cover the deficit in the short term and that's all we do with no reforms, the

stream of businesses leaving the state will turn to a flood," Rauner said. Many Democrats, led by House Speaker Michael Madigan, say Rauner's policy proposals are meant to destroy labor unions in the state, a standoff that has helped define a budget war that is approaching its one-year anniversary. "(Rauner is) not interested in finishing the job he was elected to do," state Representative Lou Lang said at a massive union rally last week. "We may or may not have a budget during the entire term of Bruce Rauner."


rank and file group of lawmakers working Abehind closed doors has sent to leadership a so-called framework of taxes and cuts that includes raising the state income tax from 3.75% to 4.85% and expanding the Illinois sales tax. Lawmakers who helped write it say that kind of tax increase plus more than \$2 billion in cuts are needed to make the state budget balance. But the idea hasn't been publicly embraced by many officials. TV and video ads already pushing lawmakers for property tax relief could foreshadow what might follow a move to raise other taxes. If neither side gives in, the Illinois budget stalemate will keep setting records. Several states in the U.S. have approved two budgets in the time Illinois has been without one.

If lawmakers and Rauner can't cut a spending deal before May 31, the Illinois Constitution requires them to get more votes to approve a new budget, making any final agreement even harder to come by. The 2011 tax increase needed fewer votes because it was done in January, when budget pressure loomed and the election was over. The same vote rules would be in place in January 2017, if the standoff continues that long.

Driver's License / ID Card Changes

Illinois Secretary of State Jesse White announced that his office is upgrading security features to the Driver's License/ID card design. With implementation of these changes, Illinois has moved closer to achieving full REAL ID compliance, which is a federal mandate of the


U.S. Department of Homeland Security (DHS). These types of anti-counterfeiting security features help prevent and deter fraud.

By the end of July, applicants visiting Driver Services facilities will no longer be issued a new permanent DL/ID card at the end of the application process. Instead, they will leave the facility with a temporary secure paper driver's license, which is valid for 45 days and will serve as their DL/ID for driving purposes and proof of identification. The temporary, secure paper driver's license or ID card will contain a photo and the basic information that appears on the permanent driver's license or ID card.

Meanwhile, the applicant's information will be sent to a centralized. secure facility in Illinois. After fraud checks have been conducted to ensure the applicant's identity, a higher quality, more secure DL/ID will be printed and sent via U.S. mail within 15 business days to the applicant's address.

The upgraded driver's license and ID card contain a variety of enhanced security features that take advantage of new developments in technology. For purposes of air travel, DHS states that it will accept the temporary document in conjunction with the old DL/ID to board an aircraft until the permanent card arrives in the mail.
