
PRESIDENT'S MESSAGE




FEBRUARY 14, 2018

The four legislative leaders officially met in the governor's office for the first leaders meeting since December 2016.

In the Governor's final budget address of his first term, he is again proposing balancing the budget on the backs of retirees, teachers. and state employees.

- > Zero out any funding for the Teachers Retirement Insurance Program
- Lower the state's cost to TRS by shifting cost to local school districts
- Slash health insurance benefits for retired teachers and state employees
- Put in place a new pension plan



- ➤ Boost funding for education by \$556 million about \$350 million of that going toward the new funding formula that was enacted last year
- ➤ Eliminate some current programs for K-12: After School Programs, Advanced Placement, After School Matters, District Intervention Funding, Parent Mentoring, National Board-Certified Teachers, School Support Services (Lowest Performing Schools), Teach for America
- ➤ Remove health insurance from the list of items that are negotiated through collective bargaining with government employee unions
- > Cut the General Assembly and judicial budgets

ADJUSTMENTS TO YOUR TRS CHECK ON FEBRUARY 1, 2018

TRS members saw a difference in the net amount of their monthly benefit checks dated February 1, 2018, compared to the checks received on January 1, 2018. Adjustments in the net amount were caused by one of the following three reasons, or by a combination of these factors:

AUTOMATICE ANNUITY INCREASE (AAI)

3%
compounded

Your annual 3% compounded AAI, sometime referred to incorrectly as a Cost of Living Adjustment (COLA), for 2018 was reflected on your February 1, 2018 check. With some exceptions, recipients of monthly survivor benefits also saw a 3%

increase. TRS pays your monthly benefit in arrears. The check you received dated January 1, 2018 was your payment for the month of December 2017. The check dated February 1, 2018 was your monthly annuity for January 2018. Under state law, the AAI increase is first effective on January 1 following either your first retirement anniversary or your 61st birthday, whichever is later, so not all retired TRS members saw an AAI increase in their February 1 check.

TRS sends a notification letter to all members before they receive their first AAI. This is the only time TRS will notify members about the annual AAI. Retirees may log into the Member Account Access area to view their monthly and annual earnings statements at https://member.trsil.org/

TRAIL INSURANCE PREMIUMS

Changes in the Teachers Retirement Insurance Program (TRIP) premiums some members pay for the Total Retiree Advantage Illinois' Medicare Advantage Prescription Drug (TRAIL MAPD) health insurance coverage was reflected on the annuity check dated February 1, 2018.



FEDERAL INCOME TAX WITHHOLDING TABLES TOOK EFFECT

Newly revised federal income tax withholding tables were implemented and took effect on your annuity payment dated February 1, 2018. These latest tax withholding tables reflect the changes in federal income tax rates that became law in December of 2017. LOCAL GOVERNMENT CONSOLIDATION

Illinois has the most units of local government of any state, according to counts from the U.S. Census. A new law aims to make it easier for counties to dissolve smaller governing bodies, such as lighting or fire protection districts, through a voter referendum. State Senator Tom Cullerton sponsored the bill that expands a model started in DuPage County in 2014. Most of these districts levy a

property tax, and the Villa Park Democrat says the law will lower real estate taxes while making local governments more efficient. "We can show people we're moving toward reducing and helping eliminate the heavy burden they're paying on their property," Cullerton said.

PENSION PAYMENT GUARANTEE IN ILLINOIS LAW

In recent years, the Civic Committee of the Commercial Club of Chicago has said that pensions due to Illinois teachers and public employees are not guaranteed by the state; implying that if a state pension system, such as TRS, goes broke, retirees have no recourse to collect the money owed them. The Civic Committee cited the Illinois Pension Code – 40 Illinois Compiled Statutes 5/22-403 – as saying that "any pension payable under any law herein before referred to shall not be construed to be a legal obligation or debt of the State..."

DISCUSSION: The pensions of all TRS members are guaranteed by the State of Illinois. In its argument, the Civic Committee does not quote the entire law when referencing the Illinois Pension Code and leaves out important language.

The entire clause reads: "...any pension payable under any law herein before referred to shall not be construed to be a legal obligation or debt of the State unless otherwise specifically provided in the law creating such fund." In other words, the language in another state law creating a pension fund can override this section of the Illinois Pension Code.

FOR ILLINOIS TEACHERS: The section of the Pension Code cited by the Civic Committee is overridden by 40 ILCS 5/16-158(c), a part of the law that created TRS in 1939. This section specifically states: "Payment of the required State contributions and of all pensions, retirement annuities, death benefits, refunds, and other benefits granted under or assumed by this System, and all expenses in connection with the administration and operation thereof, are obligations of the State." Under state law, the payment of TRS Pensions is an obligation of the State of Illinois. In addition, Article XIII Section 5 of the Illinois Constitution protects "membership" in any state pension system as an "enforceable contractual relationship."


NEVER FEAR - SPRING IS NEAR
