



PRITZKER WANTS TO PUT OFF PENSION PAYMENTS

Governor Pritzker's administration has confirmed that its new public pension plan will slash \$800 million from the state's scheduled pension payment next fiscal year, which begins July 1, 2019. That reduction is a direct result of Pritzker's proposal unveiled by Deputy Governor, Dan Hynes, which would extend the state's pension payment "ramp" by seven years, from 2045 to 2052.



"Hynes said that the priority will be identifying assets, such as buildings and land, that could be sold quickly to generate money for the pension system. Consequences of Irresponsible Pritzker Budget Proposal Will Cost Illinois and Future Generations \$150B More, Say Retired Teachers

RETIREES IMPLORE PRITZKER TO STOP RAID OF \$500M FOR 2019 PENSION FUND

Members of the Illinois Retired Teachers Association (IRTA) are imploring Governor J.B. Pritzker to cease the decades-long practice of not fully funding the pension systems. IRTA members appreciate the difficult fiscal condition that the Governor inherited but taking pension holidays is not the solution.

"The Illinois Retired Teachers Association has serious concerns about the Governor's proposed pension holiday," IRTA President Roger Hampton said. "We are supportive of the proposals to infuse additional revenues into the pension funds for solvency, but not to underfund systems by hundreds of millions of dollars or by raiding one fund to give more to another. Delaying pension payments just kicks the can down the road again and costs future generations of Illinois taxpayers (if any left) billions of dollars."

During his budget address Wednesday, Governor Pritzker proposed allocating \$4.237 billion into the Illinois Teachers' Retirement System (TRS), a figure \$576,000,000 too short of what is legally and ethically required to pay for the pension benefits of retired teachers and current teachers. It will result in reduced pension payments to TRS for years to come but will generate a nearly \$150 billion in increased costs to Illinois taxpayers, including the 417,292 members of TRS.

"TRS is currently very poorly funded by actuarial standards at 40% of the assets needed for current benefits," IRTA Executive Director Jim Bachman said. "If Illinois had not taken pension holidays, like the ones being proposed, the cost of TRS would be \$1.2 billion. The State is paying 400% more because of statutory underfunding and a history of pension holidays. The Illinois Retired Teachers do not believe that the solution to the poorly funded pension systems is to make them more poorly funded and to continue the tradition that got Illinois in this problem in the first place."

"The State of Illinois must keep its promises to the people, like retired teachers, that have always kept up their end of the bargain," Hampton concluded. "The State must fund its pensions and retiree healthcare promises at levels that are both legally and ethically justified." It should be noted that this pension holiday is focused only on teachers outside of the City of Chicago. Pritzker did propose increasing the payments to the Chicago Teachers' Pension Fund.

"These numbers prove, without a doubt, the strong impact that teachers have on the economy of Illinois," said TRS Executive Director

Dick Ingram. "Active teacher salaries and the pensions teachers receive in retirement don't disappear into thin air. The benefits are invested back into communities large and small in all 102 counties. That money finds its way into grocery stores, pharmacies, hardware and department stores, and local restaurants, as well as charities and volunteer causes," he added. "In particular, a TRS pension not only allows many retired teachers to live with safety and dignity in retirement, but also allows them to continue to be productive members of their communities."

The economic study also found that 78% of all TRS benefit recipients, or 91,694, and 97% of active TRS members, or 154,804,

reside in Illinois. Formulas used by the Bureau of Economic Analysis in the U.S. Department of Commerce determined that in 2018 TRS members' salaries and benefits added \$9.2 billion to Illinois' gross domestic product – goods manufactured and services provided. In 2017 Illinois' total GDP was \$832.4 billion. The "added value" of TRS members on the state's GDP was greater than the combined \$7.2 billion contribution of agriculture, fishing and hunting, mining and oil and gas extraction to the economy.


LEGISLATION CURRENTLY FILED IN THE 2019 ILLINOIS GENERAL ASSEMBLY



Leading Chicago Business Group Proposes Raising Income Taxes and Taxing Retirement Income to Fix Illinois' Finances

The Civic Committee of the **Commercial Club of Chicago** called for increasing the state's individual income tax rate to



rate to 8% from 7%. The plan also calls for starting to tax both retirement income and some consumer services.



To try to soften the blow of a tax on retirement income, the Civic **Committee proposes**

lessening the burden on retirees by increasing the income tax exemption for taxpayers 65 and older from \$1,000 to \$15,000.
