

#### **PARTA Luncheon Meeting Minutes**

June 1, 2015

Jean Thieman led us in the Pledge and gave the invocation. Roger Hampton then led us in singing "God Bless America". President Barnwell thanked the greeter, Becky Michel, for welcoming everyone. Attendance was 105.

Representatives from Legacy Investments, Trent Strong and Marc Minor, gave an overview of the money managed by them for PARTA. Our investments have done well under their management efforts. The total investment balance is \$41,742.84. Dave Weiman was the main speaker for the day and his topic was Care Compass – A Guide for Long Term Care. He had a list of best practices the nursing homes should follow in order for residents to be more satisfied and healthier. He is available to speak to any group who is interested in more information.

Dave then opened the business meeting.

- The minutes were in the Soundings. They were approved as printed.
- The Treasurer's Report was on the tables and will be filed for audit.
- Membership Two new members were introduced.
- Altruistic John Monks died on May 14, 2015.
- Roger Hampton, Area 4 Representative, reminded us that the Illinois Supreme Court ruled that pensions could not be diminished. Governor Rauner has not appropriated any money for the insurance subsidy, but the budget he proposed was rejected by the General Assembly, so for now, the subsidy continues.
- Sally Weber is the new Webmaster for PARTA and will have the new website available July 1.
- The meeting was adjourned.

#### PARTA Board of Director's Meeting Minutes August 18, 2015

Present: Dave Barnwell, Laveine Birditt, Maxine Blane, Nancy Wing, Jeff Vallosio, Linda Sedgwick, Roger Hampton, Terry Knapp, Sally Weber, John Rathbun, Peggy Shane, Eric Johnson, Nancy Miller, Susan Leighty, and Kathy Simpson.

Jeff distributed the Treasurer's Report. He said the investment

total value is down \$461.85 from this time last year. He had two suggestions for us to consider, but not act on at this time. First, he asked us to consider raising the life membership fee, and second to consider the need to have a little more money in an insured account. There was some discussion. John moved to accept the Treasurer's Report, Laveine seconded it, and the motion carried.

New Business: Sally said that this year, the new retirees have received a letter telling them that they're invited to the PARTA meeting in September. Linda said they will be called a week before for reservations. September's program is the Alp Horns. Larry Newman will also tell us about IRTA benefits. We will honor the new retirees with recognition and a flower. A nice list of new retirees was received from the Regional Office.

Roger reported that the IRTA Convention is scheduled for October 26-27. Dave should get a letter with a form to fill out and the cost. Shirley Horwedel will be the honoree from PARTA on Monday night. She will attend on Monday night only, with her driver as her guest. John moved to pay for all Shirley's expenses. Terry seconded the motion, and the motion was approved. Registration is Monday, from 8:00 — noon. The convention will include an inspirational speech combined with information about Abe Lincoln. Each local unit donates an auction item. We will ask for suggestions at the September meeting.

A future increase of the fee to a speaker (when appropriate) was discussed. A \$50 honorarium is given to some speakers. The budgeted amount for honoria and free meals for speakers is \$300. We may need to look at an increase for the new budget.

Old Business: Roger reported that the IRTA Legal Defense Fund has less than \$100,000 left. If there is a lawsuit, it will need more. Roger would rather wait to see if there is a lawsuit before we contribute.

According to our bylaws, we, as an organization, cannot make a donation to the Children's Museum.

#### **Committee Reports:**

 Reservations – Nancy said we would start billing for those who make reservations and don't show.



The cost is the same through December.

- Membership John said that this is the time of year when we gain new members.
- Publicity Laveine reported that the *Journal Star* can no longer get us on the monthly calendar. Terry said *Community Word*, a monthly community paper, would work with us.
- Scholarship Terry reported that we have three recipients for the ICC scholarships, all education majors. The banquet is October 22, at 6:00 P.M. at Embassy Suites. PARTA pays for two people to go. Dave will go with Terry and Sharon. The 2010 recipient, who has five children, graduated from Bradley cum laude.
- Historian Sue reported that Helen Dunn passed on several scrapbooks to finish. She will buy new ones and take the finished ones to Bradley. She will contact Frances Farraher about the names of members who have passed away.
- IRTA news and publications Roger said the September Soundings will also be mailed to new members. He reported that Sally will be the new Region 10 Director, starting January 2016. He also said that Sally is the new Webmaster for PARTA.

#### Request to extend deadline to appeal Illinois Supreme Court's Decision

In May, the Illinois Supreme Court ruled that the constitution prohibits reducing any benefits that were promised to retirees when they started in the Teachers' Retirement System. On July 28, 2015, Attorney General Lisa Madigan's Office filed a request to extend an August 6th deadline to appeal the Illinois Supreme Court's decision that protects pensions to the U.S. Supreme Court. Her office will now have until September 10 to file an appeal.

The attorney general will now have additional time to ask the U.S. Supreme Court to overrule the **Illinois Supreme Court's** decision, arguing that Illinois can institute emergency police powers, allowing the general assembly and governor to decide when they can undercut the protections listed in the pension clause of the constitution.

Senate Bill 1, passed by the Illinois General Assembly in December of 2013, proposed allowing the state to cut a retiree's cost-of-living adjustments, increase the retirement age of current employees and make cuts to the pensions of working and retired members of TRS. Their goal was to cover a nearly \$100 billion shortfall in payments to the pension systems that was caused by decades of underfunding.

John Fitzgerald, one of the attornev's representing the IRTA, says they will continue to fight if the Attorney General decides to pursue with the appeal. "This is entirely a matter of Illinois State Law. There is no basis for the U.S. Supreme Court to intervene."

The Attorney General's petition to the U.S. Supreme Court says the pension case "raises important questions" about states' rights to use police powers to modify contracts, like public pensions. The principal questions presented are:

(1) Does the reserved powers doctrine prevent a State from abdicating its police powers authority to modify its own contractual obligations in extreme circumstances that imperil the general welfare?



(2) If not, did the Illinois Supreme Court identify the correct standard by which the validity of a State's exercise of its police power is judged?

#### TRS EARNS A 4.1% RATE OF INVESTMENT RETURN FOR FISCAL YEAR 2015

Preliminary estimates indicate that Teachers' Retirement System investments generated a positive 4.1% rate of return, gross of fees, during fiscal year 2015. The preliminary 30-year investment return for TRS is 9.04%, net of fees, which exceeds the System's long-term investment goal of 7.5%. TRS ended FY 2015 on June 30 with \$45.8 billion in assets, which places the System among the top 40 largest pension funds in the United States.
