

# POSSIBLE CHANGE IN TRIP/TRAIL HEALTH INSURANCE!

The Department of Central Management Services recently concluded their review of submitted applications for health insurance carriers for the TRAIL program. Aetna Insurance Company has been chosen as the provider. United Health Care has appealed the decision. This change would be effective January 1, 2023.

This change could be problematic because of the sensitive nature of our health care needs, our relationships with our healthcare providers, and our reliance on my prescription drug coverage. Of equal concern is that the condensed timeline for the switch could result in disruptions to our care and could lead to poor clinical outcomes for us. IRTA's understanding is that this change in health insurance vendors provides no financial benefit to the State of Illinois. Given the lack of benefit to anyone involved, we implore CMS to please not rush to this change in vendors.

IRTA informed its membership of this information. This is another reason to be a member of IRTA.

IRTA asked members to contact **Governor Pritzker regarding this** matter. Did you contact Pritzker?

#### PROGRESS ON REPEALING THE WEP & GPO!

GREAT NEWS! Illinois House Resolution #0082 has passed one hurdle which would repeal the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO) of Social Security that affects many retired teachers. This bill has MORE THAN 290 co-sponsors! "The rules mandate a floor vote on any bill that receives 290 co-sponsors". These unfair, outdated provisions of the Social Security code eliminated earned Social Security benefits and must be repealed. There should be Social Security fairness for all.

Were you aware of this information? IRTA informed its membership of this information.

This is another reason to be a member of IRTA.

IRTA asked its members to please submit a personal message about how WEP/GPO has affected them to their congressman and requested to urge Speaker Pelosi to bring the bill H.R. 82 up for a vote. Did you contact your congressman?

IRTA LAWSUIT — ON YOUR BEHALF (continued from page 3) IRTA filed a lawsuit challenging the underfunding of the Teacher Health Insurance Security Fund and is proceeding in the Circuit Court for Sangamon County. The defendants have answered IRTA's complaint, and they responded to our requests for discovery. IRTA's attorneys and expert witness will carefully analyze the data they have produced about the current fiscal status of the Fund. The answer and discovery responses have pointed to one key legal dispute in this case. The defendants acknowledge that "retired teachers have a constitutionally protected right to the benefits specified in sections of the State Employees Group Insurance Act of 1971" but they "disagree that retired teachers have a constitutionally protected right to a particular program of benefits that CMS has established under that authority at any given time." This appears to mean that the defendants believe you have a constitutionally protected right to participate in some type of health insurance program, but not to any particular level of benefits. IRTA strongly disagrees with that argument and will continue to advocate for the full extent of YOUR CONSTITUTIONAL RIGHTS in this litigation.

This lawsuit is funded by IRTA members.

#### TRS COMMITS MORE THAN \$1.5 BILLION TO INVESTMENT OPPORTUNITIES

Source: https://www.trsil.org/news-and-events/TRS-Commits-More-Than-1.5B-to-investment-opportunities The Teachers' Retirement System Board of Trustees reviewed more than \$1.53 billion in investment commitments made during June and July. The System committed \$680 million and \$130 million to 12 private equity opportunities, €200 million to an opportunity in the Real Assets Portfolio and up to \$650 million to an opportunity in the Global Income Portfolio.

The Teachers' Retirement System of the State of Illinois is the 42<sup>nd</sup> largest pension system in the United States, and provides retirement, disability and survivor benefits to teachers, administrators and other licensed public-school personnel employed outside of Chicago. The System serves 434,000 members and had assets of \$63.1 billion as of June 30, 2022.
