When NOT to Take the Senior Discount

Everyone likes a good deal, but there are times when opting out of a discount is the smarter choice. The discounts are one of the great perks of reaching retirement



age. Seniors are often entitled to reduced rates on everything from airfare, cell phone plans, and car rentals to movie tickets, hotels rooms, and restaurant meals. Most of the time, taking advantage of these deals is worth it. However, Art Koff, author of *Invent Your Retirement* and founder of RetiredBrains.com, cautions that special prices should be reviewed carefully to ensure they really offer the bargains promised. Some do come with strings attached, such as restrictions on the times or days they can be used. Unfortunately, seniors can also be the targets of scams that use discounts as a lure. Next time you're tempted to take a deal, look out for these warning signs to be sure it's truly worth your while.

Restrictions: Take the discount if you are entitled to it, but realize that you are probably going to be inconvenienced a bit. Travel discounts, for example, often come with restrictions. Depending on the airline, those could include only offering the senior discount on certain routes or having





blackout travel dates. The other hassle: these senior rates are typically not offered online, so you'll have to call the airline directly to take advantage of them.

The U.S. Food and Drug Administration warns that some medicines sold online are fake, too strong or weak, have dangerous ingredients, or aren't FDA approved—and all of these differences can be dangerous to your health.

Personal Information:

Sellers could get information that could leave you susceptible to fraud or theft, such as your Social Security number or bank account information. When a consumer is asked for personal information from a company, they should first ask themselves why the company needs that information, then they



should make sure the company in question is highly reputable. Too Good to be True: The old adage, "If it sounds too good to be true, it probably is," applies when it comes to discounts. Use special caution when purchasing services that offer rock-bottom prices. The home security market is a good example of this. You might be offered an unbelievable deal to have a system installed in your home, only to discover after the fact that the company provides questionable customer service when a call for help is received. Over-the-top moving deals are another one to be wary of, as rogue movers may offer super-cheap prices upfront and then hold your processions hostage while demanding additional payments. The best way to avoid these discount scams is to do your homework before committing to a service. Get price

before committing to a service. Get price quotes from a few reputable companies and if the discount seems impossibly good, avoid it.



Rauner Questions the Need for 850-plus School Districts in Illinois

Governor Bruce Rauner said that it's a "travesty" for Illinois to be "dead last" in general funding for its schools and promised to send more money to classrooms. He told about 600 members of the Education Writers Association at

their annual conference that he is "personally committed" to increasing financial support for his state's schools, which lost millions of dollars during the financial crisis. Earlier this year, he proposed a budget that included a \$300 million increase for K-12 schools next year while calling for cuts elsewhere, including roughly \$400 million from higher education. suggested that cost saving could be found in the layers of bureaucracy within the state's 850plus school districts, some of which are just a single school. "The money should be in the classroom with the teachers, with technology, with the infrastructure and with the students. Not in the bureaucracy," he said. "We have a lot of layers that consume the money."



school districts remain throughout the state, including the Metro East. Beth Purvis, Rauner's adviser on education, said this results in misdirected funds. "When you look at all those levels of government and the money that it is taking away from the classroom — if we could get that money into the hands of principals and into the hands of teachers, that's a much more effective and efficient manner." Rauner added, "The money should be in the classroom ... not in the bureaucracy." Rauner's remarks come at a tumultuous time for Illinois schools, many of which continue to operate in the red. got to bring it back," Rauner said. "We've got to invest so that every child sees a future."



TRS Active Member Trustee Election on May 1, 2015
For the first time since 2001, an election will be held to fill seats on the TRS Board of Trustees.
Active TRS members will vote during April to select two trustees from four candidates. Ballots will be counted on May 1 and the two trustees will assume their duties on July 15, 2015.

NOTE: Retired TRS members are not eligible to vote in this election.

Eligible voters are active members listed in payroll records filed with TRS as of March 1, 2015. The two seats to be filled this spring must, by law, be elected by active members.

The candidates vying for the two seats are: Bradley D. Cauffman, Hilde I. Elg, Andrew J. Hirshman and Cinda J. Klickna. Under state law, six members of the 13-member Board are elected by members – four by active members and two by annuitants. The trustees serve staggered four-year terms. Six members are appointed by the governor to serve staggered four-year terms. The 13th member, the president of the Board, is the state superintendent of schools.

Never Use the Cruise Control When the Road is Wet or ICY

Do not engage your vehicle's cruise control on slippery or wet roads. Snow, ice, slush, or even rain can cause wheel-spin and loss of control, situations to which drivers must react quickly.



Although cruise control can generally be cut off by the driver's simply tapping the brake pedal, the extra reaction time required for a motorist relying upon cruise control to recognize the danger of the situation when his wheels begins to spin or slide on a slippery surface, bring his foot up off the floor to the brake pedal, and disengage the cruise control can be crucial.

Turnaround Illinois PAC Will Let Rauner Reward Friends, Punish Enemies

Governor Bruce Rauner devised a new way to reward his friends and punish his enemies on April 16th when he created a campaign committee called *Turnaround Illinois*. Turnaround Illinois is an independent expenditure

committee; meaning contributions to it and by it are not capped by law. The committee's officially stated purpose is to "support state legislative candidates who support Rauner's bold and needed reforms, and to oppose those who stand in the way." According to Rauner insiders, the new committee will be given \$4-5 million within days of its founding. That's in addition to the \$20 million the governor has in his own personal campaign account, which won't be touched for this particular effort. Spending on advertising is expected to begin soon after the money comes in.

The governor's campaign also released a polling memo which purports to show that the public backs his agenda. While his job approval rating is just 38%, his disapproval rating is five points below at 33% and his favorable rating is 42%, versus 34 who view him unfavorably.

By contrast, the General Assembly's job approval rating is a mere 20%, with 57% disapproving. House Speaker Michael Madigan's favorables are just 24%, with 51% viewing him unfavorably.

The poll also found that 57% agree with: "Rauner is trying to shake things up in Springfield, but the career politicians are standing in his way," and 56% agree that the governor is "working to find bipartisan solutions that will help fix Illinois's budget mess and improve the struggling state's economy."

The "austere budget" is being talked up by Rauner insiders as a way of forcing Democrats to cave on things like local "right to work" zones. They firmly believe that if they refuse to back any additional revenues for next fiscal year, Democrats will eventually have to recognize reality and give the governor what he wants.



The issue questions are clearly loaded. For instance, check out part of the "right to work" question: "Under current Illinois law, workers are often required to join a labor union and pay union dues as a condition of their employment. In other words, the worker cannot take a job unless he or she joins the union."

Not mentioned is that Rauner wants to allow employees who receive all the benefits of union membership to not have to pay for those valuable union services. It's like passing a law that lets newspaper advertisers off the hook for paying for their ads.



But when you essentially have unlimited resources and the other side doesn't, as is the case with Rauner versus the Democrats, you can frame an advocacy campaign pretty much any way you want. We've entered an entirely new world, campers.

NEW STATE SUPERINTENDENT OF SCHOOLS TONY SMITH

The State Board of Education appointed a new State Superintendent of Education, Dr. Tony Smith.

As a result, he also becomes the new president of the TRS Board of Trustees.

The state is adjusting to new state standardized tests, with some students opting out of taking them. The Illinois State Board of Education named a

new superintendent, Tony Smith, who most recently led the Oakland School District in California. Smith replaces Chris Koch, who served as superintendent for nine years. Rauner told the Chicago Tribune recently that Koch was not "transformational" enough. Rauner said he wants vocational training to return to high schools, which lost many of their programs in the 1980s.

A key member of the Illinois State Board of Education has formally resigned over concerns about the way new state Superintendent Tony Smith was hired. The Chicago Tribune reported that resigning board member James Baumann said there was no national search and only one candidate for the state's top schools position. Smith is the former head of Oakland, California, schools and has ties to Governor Bruce Rauner. He also was Rauner's recommendation to the board. The Republican governor recently appointed five new board members to the nine-person board. At least two previous state superintendents were hired after a national search, including current state Superintendent Christopher Koch.
