The meeting was adjourned for the Christmas Sing. Denise Adams conducted a few tunes from the musical, "Chicago," and Lee Wenger led the members in Christmas songs.

PARTA ZOOM BOARD MEETING MINUTES NOVEMBER 27, 2023 9:30 A.M.

The PARTA Board met via Zoom on November 27, 2023, at 9:30 AM. Members present were Jeannie Blane, Roger Hampton, Abby Humbles, Jeff Vallosio, Dixie Wheeler, Patti Monks, Valda Shipp, Peggy Shane, Dave Barnwell, Sally Weber, and Deloris Turner.

The meeting was called to order by President Wheeler, who led the Pledge to the Flag.

COMMITTEE REPORTS

TREASURER REPORT: Jeff Vallosio stated that the Investment Committee decided to withdraw \$2,000 from the general fund. The committee had budgeted \$3,000 but found it necessary only to withdraw \$2,000. The February report will reflect that transaction. The next Finance Committee meeting is scheduled for February 26, 2024, at 1:00 PM.

The Board used the October Celebration of Life list for IRTA for memorials. The amount sent for each deceased member is \$10.00.

FINANCE COMMITTEE: Dave Barnwell reported that despite the uncertainty of the current stock market, we have done an excellent job of holding our own. PARTA is in pretty good shape.

ATTENDANCE/RESERVATIONS: Patti Monks reported sending out bills, and members have been responsive. Patti suggested that recognition should be given to the volunteers at the "back table." Some of the volunteers do double duty. Jeff complimented Patti on turning in bills for five (5) people. Patti

GREETERS/INVOCATION: Peggy Shane reported that the schedule for Greeters and the Invocation is complete. Dixie reminded Peggy to make sure the names for Invocation and Greeters are submitted to Roger to include in the Soundings.

LEGISLATION: Dixie Wheeler stated that there is nothing regarding retired teachers going on right now legislative-wise.

PARTA ICC SCHOLARSHIP: Valda Shipp mentioned that the initial recipient of our scholarship, Katrina Johnson, could not fulfill her courses and withdrew. She was replaced with Trenton Spangler from Washington, Illinois, who is excited to have received our scholarship and is looking forward to making an impact as a teacher.

PARTA TEACHER GRANTS: Deloris Turner informed the board that the PARTA Teacher Grant information will be sent out to schools via the Regional Office of Education in the second semester.

PARTA DIRECTORY: Denise
Smith is currently keeping the directory updated.
The directory is printed every other year. There was much discussion on the best way to distribute copies of the directory to members.
There were many opinions on maintaining the directory in print form or online. Valda Shipp suggested we poll the membership at the December meeting to determine whether they wanted printed, online, or both.





READING CAN HELP STAVE OFF DEMENTIA

Brain-stimulating activities, like reading, have been shown to ward off mental decline, as well as conditions such as dementia and even Alzheimer's. Research found that older people who read have a 32% lower rate of declining mental abilities. This is because reading has been shown to put our brains into a state similar to meditation. In doing so reading brings the same health benefits of deep relaxation and inner calm. Regular readers have been shown to have lower stress levels and decreased rates of depression compared to non-readers. Additionally, readers tend to sleep better

and have higher self-esteem.
