SENATE PROPOSALS BOTH 'UNFAIR' AND 'UNCONSTITUTIONAL'

Members of the Illinois Senate voted on two separate bills that directly affect all annuitants of the Teachers Retirement System. SB 42, sponsored by Senator



Andy Manar, would have ended the continuing appropriation for the Teachers' Retirement Insurance Program (TRIP) in state statute. The other piece of legislation, SB 16, is the pension reform proposal sponsored by President Cullerton and touted by Governor Rauner. Once again, this legislation does several things, but

most importantly, it will lower the amount the state pays into the pensions systems. IRTA states, "this essentially creates another pension ramp and pushing off the pension payment is the same mentality that got the state into this mess in the first place".



In addition, it will require active teachers and other current state employees to make a choice. They can choose to keep their compounded COLA in retirement, but can no longer have pay raises count toward their future pensionable salary. Or they can give up the compounded COLA, but continue having raises count toward their retirement benefits and be placed into the Tier II pension plan. Not only are these measures unfair, IRTA suggests the changes proposed are unconstitutional. The lawyers who represented the IRTA Members against SB 1, Gino DiVito and John Fitzgerald, recently wrote an opinion concerning proposed "consideration" language presented in this bill. SB 42 failed, but only by three votes and there has been a motion to reconsider the vote. SB 16 passed the chamber and now goes to the House of Representatives for their consideration.

Excerpts from "Baseball and Football", by George Carlin

Baseball is different from any other sport, very different. For instance, in most sports you score points or goals; in baseball, you score runs. In most sports the ball, or object, is put in play by the offensive team; in baseball, the defensive team puts the ball in play, and only the defense is allowed to touch the ball. In fact, in baseball if an offensive player touches the ball intentionally, he's out; sometimes * BIHCIAL * MAJOR LEASUE BASEBALL unintentionally, he's out.



In football, you score with the ball and in baseball the ball prevents you from scoring. In most sports the team is run by a coach; in baseball, the team is run by a manager. And only in baseball does the manager or coach wear the same clothing the players do. Football is concerned with downs - what down is it? Baseball is concerned with ups who's up? In football, you receive a penalty. In baseball, you make an error. In football the specialist comes in to kick. In baseball, the specialist comes in to relieve somebody. Baseball has the seventh inning stretch.

Football has the two-minute warning. Baseball has no time limit: we don't know when it's going to end might have extra innings. Football is rigidly timed, and it will end even if we've got to go to sudden death. In baseball, during the game, in the stands, there's kind of a picnic feeling; emotions may run high or low, but there's not too much unpleasantness. In football, during the game in the stands, you can be sure that at least twenty-seven

times you're capable of taking the life of a fellow human being.



And finally, the objectives of the two games are completely different. In football the object is for the quarterback, also known as the field general, to be on target with his aerial assault, riddling the defense by hitting his receivers with deadly accuracy in spite of the blitz, even if he has to use shotgun. With short bullet passes and long bombs, he marches his troops into enemy territory, balancing this aerial assault with a sustained ground attack that punches holes in the forward wall of the enemy's defensive line. In baseball, the object is to go home! And to be safe! I hope I'll be safe at home!

SB 42 Passes Senate; Reinstates Appropriation Retiree Healthcare

Members IRTA are praising lawmakers for not passing another unconstitutional

measure aimed at diminishing benefits for retired teachers. The Illinois Senate voted Tuesday, May 23, on a bill that provides contributing funding for the Teachers **Retirement Insurance** Program (TRIP). "It is unimaginable to think what retired teachers and families would endure if the continuing appropriation was eviscerated," IRTA President Dave Davison said. "We continue to sound the alarm that it would be catastrophic to retired educators."

SB 42, sponsored by Senator Andy Manar, was amended and passed to reinstate the continuing appropriation for T.R.I.P. in state statute. The bill when originally proposed last week, did not include the provision to sustain the TRIP continuing appropriation. "IRTA members and their families spoke loudly and firmly that promised healthcare benefits cannot be diminished," Mary Shaw, IRTA **Governmental Affairs Director** said. Thousands of our members contacted their senators when this bill was originally proposed, and today we know that legislators heard the message." The bill now goes to the House of **Representatives for** consideration.

The IRTA has been advised by Tabet DiVito & Rothstein LLC that, "Retired Illinois educators' health insurance benefits are protected by the Pension Protection Clause for the reasons set forth in Kanerva v. Weems." "The IRTA believes that not funding TRIP is not only unfair, it is unconstitutional," IRTA Executive Director Jim Bachman said. "IRTA

will protect and defend the benefits promised to retired educators."



In 2015, the IRTA successfully defended an unconstitutional assault on pension benefits that were put in place by then Governor Quinn when he signed SB 1 into law. On May 8, 2015, the Illinois Supreme Court unanimously struck down the state's 2013 pension reform law, SB1, upholding a lower court ruling that it violated the state constitution under the pension protection clause.

IRTA is a not-for-profit, non-partisan organization of retired educators. The Association serves the needs and interests of its members through advocacy, education, cooperation, and socialization in a flexible organizational structure.


