

Business Meeting


Jeff Vallosio announced the Treasurer's report is on each table. Also, IRTA membership information and brochures are available at the back table.





DOES TRS HAVE YOUR CURRENT INFORMATION?

Did you receive your Illinois Teachers Retirement System (TRS) Spring 2023 issue of their newsletter, *Topics & Reports*? Three issues are published and sent to all annuitants each year. If you did not receive this issue of their newsletter, TRS may not have your current contact information – along with other important items.

You are advised to access your TRS online account to confirm and edit any information that needs to be updated. You can also print a TRS Member ID Card from this website.

TRS PENSION CHECK FEDERAL INCOME TAX WITHHOLDING

TRS cannot give tax advice. You may wish to contact a qualified tax advisor or the Internal Revenue Service at 800.829.1040 to ensure that you have adequate federal withholding for the 2023 tax year. If you are underwithholding, there could be a negative consequence at tax time.

If you would like to change your withholding election, you must complete a new Form W4-P. You can call your local Internal Revenue Service office for a blank form or download the blank form from the IRS website:

www.irs.gov/pub/irs-pdf/fw4p.pdf A new Form W4-P replaces any former withholding on file with TRS.

GIVING BACK AS A COMMUNITY - EMPOWERING OTHERS THROUGH ACTS OF GENEROSITY

It's about being a part of something bigger than yourself.

For three days, Fred Barley had been sleeping in a tent on the campus of Gordon University in Georgia. Hungry and homeless, he had been unsuccessful in finding work, which he needed to survive. As two police officers approached Fred, they questioned him why he was sleeping on campus. What they then

learned affected them profoundly. Fred had traveled six hours on a bicycle in 100-degree weather so that he could attend his second year in college. With no support, his plan was to camp until school began a few weeks later, and during that time, Fred had hoped to find work.

Touched by this 19-year old's desire to succeed, the two officers spent their own money for a motel room for Fred. Word then traveled throughout the community about Fred's situation and their acts of generosity. The owner of the motel allowed Fred to stay there until school reopened. A local pizzeria gave Fred a job as a dishwasher. And most importantly, the community started a GoFundMe donation page for Fred that raised over \$180,000. What began as acts of generosity by two officers blossomed into an entire community giving back. Today, the community of Conyers continues in these efforts by launching several charity events to help low-income families.



Both the House and Senate have set to adjourn spring session on May 19th, which is much earlier than the May 31st adjournment date in the past. With a deadline coming up in both chambers to get bills out of committee, the General Assembly will have their work cut out for them.

SENATE BILLS

1345 Allows noncitizens of the United States to register to vote in school board elections.

2348 Requires school districts to provide 20 minutes of relaxation activities per week, such as yoga, meditation, or stretching, in addition to and not replacing recess.

HOUSE BILL

2789 Secretary of State Alexi Giannoulias, who is also the state librarian, is spearheading legislation that would make state grants to libraries contingent on their establishing "a written policy prohibiting the practice of banning books." At stake is about \$61 million annually to 1,600 public and school libraries. The legislation, HB2789, sponsored by Representative Anne Stava-Murray, won House approval 69-39 last month and awaits action by the Senate. Illinois would be the nation's first state to adopt such a policy, according to Giannoulias. However, it is far from the only state dealing with contention among the stacks. The American Library Association compiled 1,200 challenges to books nationally in 2022, nearly double the record number a year earlier.

IBHE Awards Over \$3 Million in Early Childhood Worker Grants

The Illinois Board of Higher Education (IBHE) has awarded \$3.37 million to two public and two private Illinois universities to support individuals aspiring to work in early childhood care and education. The grants will support scholarships and other supports for 78 students pursuing master's degrees at Illinois State University (\$800,753), Lewis University





(\$358,390), National Louis University (\$1,191,511), and the University of Chicago Illinois (\$1.027,989). The students in these programs are expected to graduate in summer 2024. "The grants will help increase the diversity of faculty in early childhood education in Illinois at a time of great need by expanding the educational pipelines for aspiring early

childhood faculty," IBHE Executive Director Ginger Ostro said in a statement. "We are excited to partner with the four selected universities to continue to make progress toward a high-quality early childhood education system in our state." Early Childhood Faculty Preparation Grants are a part of the Early Childhood Access Consortium for Equity (ECACE) initiative. ECACE is a collaboration between IBHE and the Illinois Community College Board, in partnership with the Illinois State Board of Education, Illinois Student Assistance Commission, Governor's Office of Early Childhood Development, and Illinois Department of Human Services. ECONOMIC IMPACT OF DEFINED BENEFIT PENSION EXPENDITURES IN ILLINOIS

Benefits paid by state and local pension plans support a significant amount of economic activity in the state of Illinois. Pension benefits received by retirees are spent in the local community. This spending ripples through the economy, as one person's spending becomes another person's income, creating a multiplier effect. In 2020, expenditures stemming from Illinois state and local pensions supported:



- 166,489 jobs that paid \$10.4 billion in wages and salaries
- \$30.3 billion in total economic output
- \$4.0 billion in federal, state, and local tax revenues
- → Each dollar paid out in pension benefits supported \$1.40 in total economic activity in Illinois.
- **→** Each dollar "invested" by Illinois taxpayers in these pension plans supported \$3.88 in total economic activity in the state. Source: www.nirsonline.org/
