# IRS WARNING TO RETIREES: AVOID A SURPRISE TAX BILL

With tax reform bringing major changes, the Internal Revenue Service urges retirees to make sure they are paying enough tax during the year by using the Withholding Calculator available online at:



https://www.irs.gov/individuals/irs-withholding-calculator
The Tax Cuts and Jobs Act, enacted in December 2017, changed the way tax is
calculated for most taxpayers including retirees. Among other reforms, the new law
changed the tax rates and brackets, increased the standard deduction, removed
personal exemptions and limited or discontinued certain deductions. As a result,
many taxpayers may need to raise or lower the amount of tax they pay during the
year. For retirees who receive a monthly pension or annuity check, this may mean
changing the amount of federal income tax they have withheld.

# TEACHERS' RETIREMENT INSURANCE PROGRAM (TRIP)

On August 22, 2018, SB 3046 was signed into law amending legislation to allow former TRIP members and dependents who previously opted-out of their health benefits plan, to be allowed to opt-back-in during an open enrollment period or other qualifying enrollment opportunities.



This bill was an initiative of IRTA. The law became effective immediately.

- ➤ For non-MAPD (Medicare Advantage Prescription Drug) members, your next Open Enrollment opportunity will be during the month of May 2019. Members who changed insurance providers during May 2018 should have received new insurance cards. If you have not yet received your insurance cards, please contact your plan administrator.
- ➤ For Medicare-eligible members, the 2019 TRAIL Medicare Advantage Prescription Drug (MAPD) Open Enrollment period will run October 15 November 15, 2018. Information to be mailed no later than early October.

#### TRS EARNS AN 8.45% RATE OF INVESTMENT RETURN IN FY 2018

Teachers' Retirement System (TRS) investments generated a positive 8.45% rate of return, net of fees, during fiscal year 2018 – a return that exceeded the System's custom investment benchmark of 8.19%. TRS ended FY 2018 on June 30 with \$51.5 billion in assets, an increase of 4.2% during the year. Gross of



fees, the TRS return for FY 2018 was 9.17%. TRS long-term investment returns continue to exceed the System's goal of 7%. For FY 2018, the 30-year net of fees return was 8.4%; and 9.2% for 40 years.

"TRS continues to earn better-than-expected returns on its investments using a diversified strategy that carries less risk than most of our peer systems' investments," said TRS Executive Director Dick Ingram. "That's good news for our members because the financial challenges TRS faces now and in the future require us to balance two critical mandates: Do everything we can to safeguard our members' money while prudently maximizing investment revenue."



"Because state government has failed to adequately fund TRS for the last 80 years, the system only has 40 cents in the bank for every \$1 we owe each of our members," Ingram added. "Risk management is critical because every dime is important. We know we can't invest our way out of our funding shortfall. Our future sustainability relies on consistent and adequate state funding to pay down this debt."

Ingram stressed that the 30-year and 40-year rate-of-returns are the most important numbers in the FY 2018 investment data. These timeframes not only reflect the long-term relationship that TRS has with its members but indicate a successful investment program that values steady growth and strong risk management over several generations.

The following changes to the PARTA Policies on pages 51 – 52 of the PARTA Directory were voted on at the August Board of Directors meeting and approved for recommendation to the general membership for consideration at the September meeting and for voting at the October meeting.



- 1. Delete all of # 6, "The Treasurer must have the names of guests and program expenditures prior to the meeting in order that the checks are prepared. (Use voucher.)"
- 2. Change #11 to read, "The Altruistic Chairperson shall annually submit to the Treasurer a listing of deceased PARTA members so that the Treasurer can forward the listing to the IRTA Foundation along with a \$10 memorial contribution per deceased member. A note should be sent to the family by the Altruistic Chairperson notifying them of the memorial."
- 3. Delete the first sentence of #16. Change policy to read, "All monies received shall be deposited into the general operating checking and/or savings accounts. All life membership dues shall be added to the Life Membership Fund line on the periodic treasurer reports."
- 4. Change #17 to read, "The Life Membership Fund monies shall be invested and accounted for separately from the general operating checking and/or savings accounts. Only the dividends and interest earned may be used for PARTA operational and administrative expenses."

These changes/revisions will bring the written/approved procedures into alignment with actual practices that have been followed for a number of years.

5. Revise Article IV, E to eliminate "Advisory" and "Retirement Education" from the list of standing committees.

This change of Article IV reduces the number of committee chairpersons, which lowers the number of Executive Board members needed for a quorum.

#### ONE-YEAR RETIREE RETURN TO WORK PROGRAM IN EFFECT

Public Act 100-0743 is a one-year program that expires on June 30, 2019. It allows a TRS retiree to return to work without post-retirement limitations. The regional superintendent must designate the employment to be in a subject shortage area in order for a retiree to be able to return to work without limitation.






